Purpose of the Dialogue: Facing COVID-19 crisis, we are here to ensure healthy lives and Promote well-being for all at all ages. In particular it is important to address healthcare resources and policies to prepare against health emergency crisis, through building a resilient global community. GHIPP organized a series of Global Dialogue on Health Security for strengthening global partnership through sharing knowledge and lessons learned and creating a new regional community for health resilience. Having a series of online speakers' sessions, the project focuses on building collaborative Asia-US-Japan platform for knowledge & experience sharing, and discusses how to best prepare and lead dealing with future health crises. Laurie Garrett wrote her first bestselling book, THE COMING PLAGUE: Newly Emerging Diseases in a World Out of Balance, while splitting her time between the Harvard School of Public Health and the New York newspaper, Newsday. In the 1992-93 academic years Garrett was a Fellow at Harvard, where she worked closely with the emerging diseases group, a collection of faculty concerned about the surge in epidemics of previously unknown or rare viruses and bacteria. The book was published in hardcopy by Farrar, Straus, and Giroux in 1994, and spent 19 weeks on the New York Times bestseller list. Released in paperback in 1995 by Viking Penguin, THE COMING PLAGUE remains in print and continues to sell vigorously.

Contents and Achievements:

We learned Taiwan's Experience and effort to contain COVID-19 from Dr. Chang's presentation that Taiwan's critical approach was led by community-based clinics, Taiwan's Medical Associations played a major role to coordinate regional associations to share critical information both clinicians as well as general public. Grassroot initiative to detect potential patients in early phase resulted successful containment of COVID-19.
