- Cost effective in fulfilling the 3 aims.

During this academic year, we have held 5 workshops.

- The first 3 workshops are fully sponsored by Utokyo. Dr. Minchung Hsu's Kakenhi paid for the 4th workshop. Only the 5th workshop was paid by GRIPS short-term conference fund.
- Since this workshop has only one organizer and hires no assistant, it was difficult to take pictures during the workshop.

Content: In both meetings Dr. Lavy gave generous advises on time management and possible directions of future research. He shared his personal experience of overcoming identification problems in various settings in empirical work. Also, he recommended several workshops and conferences that we should participate in the future. He helped me link to the network of empirical economists in Europe.

Evaluation and Achievement

This is the 8th GRIPS-UTokyo Empirical Workshop. We invited Dr. Lavy (Warwick University and Hebrew University of Jerusalem), a world-class labor economist, keynote the workshop. We openly invited paper submissions from faculty members and students at GRIPS, Utokyo, and other universities and research institutes. We received 7 submissions. Through a single-blinded review process, Dr. Lavy selected 3 papers to be discussed in the workshop. The selected speakers include:

- Dr. Yasuyuki Sawada (Asian Development Bank and University of Tokyo)
- Ryuichi Tanaka (University of Tokyo)
- Stacey Chen (GRIPS)

UTokyo also invited Dr. Ioana Marinescu (University of Pennsylvania) to present her recent work.

The workshop attracted leading scholars to submit papers, and gathered more than 30 senior and junior scholars from University College London, University of Tokyo, Tohoku University, Keio University, JICA, and other universities and research institute. Discussion and Q&A during the workshop were active and constructive.

The co-organizer, Dr. Hide Ichimura, and other colleagues from University of Tokyo expressed enthusiasm to continue this high-quality workshop in the unique style. Dr. Yasu Sawada (Asian Development Bank and University of Tokyo) also invited me to organize a potential joint workshop around 2018 December.
