- Play a crucial role in designing and developing overall policy direction to the Industrial Sector through identifying core competencies, macroeconomic environment, tariff and non-tariff business conditions through close interaction in-house and with different government departments and relevant stakeholders.

Engineering Development Board (EDB) Role

Develop a long-term vision for the development of the industrial sector.

- Formulate and coordinate all government policies relating to the industrial sector.
- ➢ Promotion of export.
- ≻Enhancement of technical training.
- Formulate policies and guidelines for utilization of technology development and funds.

 - Ministry of Finance/FBR on various notifications, policy issues and tariff rationalization etc.
 - Ministry of Science and Technology/PSQCA for Standards and Quality, PCST on Technology foresight
 - Board of Investment (BoI) for Investment facilitation
 - Ministry of Communication on Road Safety and Motor Vehicle regulations

Policy Formulation

- Mol&P/EDB is working on policy formulation and implementation for facilitating and encouraging development & growth of the industrial sector of the country. In this regard MolP/EDB finalized and got approved Electric Vehicle (EV) Policy-2020 for 2/3 Wheelers, Heavy Commercial Vehicles and Four Wheelers, Mobile Device Manufacturing Policy-2020 from Cabinet and is also successfully implementing pervious Automotive Development Policy 2016-21.


Automotive Development Policy-2016-21

- Federal Government of Pakistan has approved Automotive Development Policy (ADP) - 2016-21 through ECC of the Cabinet on March 18, 2016 which is effective from July 1, 2016. Following are the Salient Features of ADP.
- New Investment Incentives (Greenfield, Brownfield).
- Five Year tariff plan for existing OEMs,
- To curb misuse of Import Policy (vehicles),
- Provide regulatory and enforcement mechanism for Quality Safety & Standards (WP-29, JICA's Support)
- Establishment of Pakistan Automotive Institute (PAI)
- Ensure Consumer Welfare, KIBOR+2%, immobilizer

MAIN OBJECTIVES OF ADP-2016-21

- Facilitate higher volume, more investment, enhanced completion and better quality with latest technology
- Creating a balance between Industrial Growth and Tariffs to ensure sustainability of all stakeholders
- Ensuring consumer welfare
- Providing Policy Consistency and Predictability for investors and mid-term review to cater for emerging developments

AIDC Role

- In Pakistan, the Auto Industry Development Committee (AIDC) established with the role in inter-ministerial and public-private coordination to promote the formulation and implementation of automobile industry policies. As a forum for dialogues between the government and the industry, AIDC, with EDB as its chair, aims to promote public-private partnership in the automotive industry by establishing quality and standards, developing trade opportunities, and providing advice on investment.
- A total of 33 AIDC meetings have been held so far since 2007.
