## 1. Course Description and the Learning Objectives :

### [Course Description]

The purpose of this course is to provide a basic understanding of Japan through the discussion of its history and culture. In particular, the course examines the major transformations, issues, and challenges faced by Japan from ancient times to today, exploring domestic socio-political-economic and cultural developments, as well as Japanese relations with the world. The following main questions will be addressed during the course: what are the important transformations in Japanese history and culture? What factors explain change and continuity? How has Japan interacted with other countries in the course of its history? Through this course, students can gain a basic understanding of some of the major historical and societal developments and policy issues in Japan, and can acquire the ability to identify and explain factors shaping major processes and decisions by Japanese leaders. Such learning also contributes to deepen understanding of contemporary Japan and its people. During the course, some videos will be shown and one or two classes will be held in the form of a field trip to a site related to the contents of the course.

## 1. Course Description and the Learning Objectives :

### **Course Description:**

This is one of the most important required courses for the G-cube students. Only those G-cube students who have passed the Qualified Exam earn credits from taking this course, while other G-cube students and students in other programs are welcome to participate in this course. The students taking the course for credits should make presentations of their research in progress in front of fellow students and professors twice and submit a part of dissertation at the end of the term you make presentation.

The course will help presenters improve their presentation skills and research quality. The presenters should be precise but creative in their presentation so that they can induce critical and constructive comments from other participants. They might face provocative comments but should learn how to balance the ego against them. The students other than the presenter of the day will also benefit a lot if they try to learn from the mistakes as well as the successes made by the presenter. The participants can learn how to learn new things by listening to others, how to make constructive (and hence impressive) comments, how to ask valuable questions and so on.

Impressive comments at meetings and conferences are highly valued. Having a PhD is somehow similar to having an international driving license, which allows you to attend any international conferences or workshops. If you cannot ask any good question or make any good comment, however, you will be ignored at the reception, make no new friends, and feel miserable. This course offers invaluable opportunities to be a bona fide researcher who excel at doing research, presenting their findings, and enriching communication in academic community.

### **Course Goals**

Students can:

- (1) be precise but creative in their presentation so that they can induce critical and constructive comments from other participants,
- (2) be an impressive academic audience by making constructive (and hence impressive) comments and nurturing the skills to ask valuable questions
- (3) enrich and deepen their research project through interactions with instructors and students who are not necessarily share the area of expertise with the student.

## 1. 本授業の概要及び到達目標：

【目標】本講義は、履修者が「国際関係の基本的枠組み」、「日本外交の課題」、「日本外交の系譜」、「日本経済発展」について学ぶとともに、スピーチ作成など「対外発信力」を強化することで、将来の国際交渉を行う際に世界的課題を広い視点から自分の頭で考え発信できるようになることを目指す。

### 【概要】

・講義は著名な学識経験者や経験に富む実務家によってオムニバス方式で行われる。また外交アカデミーⅠと外交アカデミーⅡを通して全体のプログラムを組むため、実際の講義は各講師と調整し順不同で行われる。講師及び講義名を含む講義日程は、事前に通知するので必ず確認すること。

・「必読文献」や「推薦文献」ほか事前課題などは各講師の判断により提示される。通知される内容を確認のうえ、事前事後の研鑽に活用し授業外学修に努めること。

・講義を中心に授業を進めるが、質疑応答・討議の時間も十分確保することとし、出席者の積極的な議論参加を求める。

## 2. 各授業のテーマ：

### 【国際関係の基本的枠組み】

#### (1) 国際関係論の系譜

国際関係論の系譜について、明治期日本の論考やカント等の古典を紐解きつつ、枠組みの全体像を俯瞰し論じる。

#### (2) 国家と国際関係

国民国家やその関係について、その形成過程を論じることにより、現在の国家や国際関係の概念がどのように発展してきたかを解き明かす。

#### (3) 経済と国際関係

経済上の力関係の変化が国家間の関係にどのように影響を及ぼすのか、長期的なパワー・トランジション、覇権国の交代や国際秩序といった今後の可能性と我が国の課題を論考する。

#### (4) (5) (6) 国際法①②③

国際交渉の基礎であり今や膨大な体系となった国際法につき基本的枠組みとその事例提示しつつ、3回にわたる講義の中で、情報・宇宙といった新たな交際法上の課題についても解説する。

### 【日本外交の課題】

#### (1) (2) 安全保障①②

日本を巡る安全保障の現況と政策を「北朝鮮の核・ミサイル開発、中国の台頭、日本の対応」と「日本の安全保障政策と日米同盟」といった多角的視点から論じる。

#### (3) (4) 経済安全保障①②

世界貿易体制の現状を俯瞰するとともに、先端技術開発や新型コロナ後に起こりうる変化をふまえつつ、我が国の経済安全保障政策を論じる。

#### (5) 経済連携とルール形成戦略およびビジネスと人権

激動するグローバルな通商への対応は、経営への影響が大きく官民による積極的対応が必要なこと、また、官民連携によるルール形成戦略を通商政策の柱とすることが必要なことを、実証的に論じる。

#### (6) 国連の抱える課題と日本の対応

戦後のリベラルな国際秩序が政治的、経済的にも社会的にも深刻な挑戦に直面しているが、秩序の守り手である国連はどのような役割を果たしうるのか、また日本はどのように対応すべきかを論じる

#### (7) 国際交渉の現場と理論

国益をかけ対応しなければならない国際交渉の現場では、何を守りどう対応すべきか、現場での実態を踏まえつつ論考し、実践的な課題（架空の経済的交渉）の研修も合わせ行う。

#### (8) エネルギー情勢の変化と日本の対応

急変する世界情勢とエネルギー情勢を俯瞰した上で、技術の急速な変化も踏まえつつ、我が国としての最適なエネルギー政策をどのように考えていくべきかを論じる。

#### (9) 国連と社会的課題：ジェンダー

開発途上国か先進国化を問わず、世界の共通目標としてSDGsに取り上げられているように、ジェンダーの問題は広範な影響を持つことを論じ、多面的な対応を必要としていることを考察する。

### 【日本外交の系譜】

#### (1) (2) 日本外交における対外認識とリーダーシップ①②

明治維新誕生に果たした武士階級の統治者の役割や、日本としての近代国家がどのように作られ、第二次大戦に至るまで政治決定のあり方がどのように変質していったか、また同様に戦後についても政治決定のあり方がどう変遷したかを論じる。

#### (3) 中印関係の現代史と日本

やがて世界の超大国になるとされる中印関係に秘められた深刻な相克についての現代史と我が国の外交関係をたどりつつ、将来への課題を論じる。



#### (4) ODA 政策の軌跡と課題

我が国 ODA を論じる際によくある誤解を正しながら、現在ある ODA 政策の根源を解き明かし、今後の我が国の ODA 政策をどのようなものとすべきかにつき討議する。

#### (5) アジア外交の展望

世界の富と力の分布といったマクロの趨勢を俯瞰しつつ、米中対立などアジアで起きている変化を論じ、日本として、どのような対アジア外交を展開していくべきかを論じる。

### 【日本経済発展・技術開発】

#### (1) (2) (3) 日本経済発展史①②③

海外で最もよく質問される日本の経済発展について、時代区分（Economic Development-Meiji Era-Taisyo-Early Syowa, Postwar Recovery and High Growth, Economic Maturity and Slowdown）を追って学びなおす。（使用言語、英語）

#### (4) 世界経済史から見た日本の成長と課題

近年の日本経済の停滞を世界史的視点で分析しつつ、日本経済を成長させるためにはどのような政策が必要かを論じる。

#### (5) DX の思考法

DX の基礎となる思考法論じ、デジタル時代の歩き方を説く。AI やディープラーニングの思考法を議論しつつ、デジタル化がもたらすインダストリアル・トランスフォーメーション（IX）についての理解を深める。

#### (6) デジタル通商とデジタル貿易

国境を越えたデータ流通の分断化と最澄和の動きを追いつつ、我が国のデータ産業の特色とデジタル産業を日本の競争力に結び付ける政策や多国間ルール形成における今日的課題を論じる。

#### (7) 危機管理と技術開発

技術開発政策に不可欠な危機管理の視点について、実例をもとに理解を深める。その上で改めて技術開発の方向性を論じる。

#### (8) 先端技術と安全保障

米国における近年の政策と我が国の技術開発を俯瞰しつつ、経済安全保障の観点に基づく先端技術開発政策を論じる。

### 【国際発信力強化】

#### (1) ～ (5) スピーチ作成・対外情報発信

我が国首相や世界のトップ・リーダーのスピーチがどのように作られるのかを分析しつつ、スピー

チとは何か、優劣を分かちポイントは何かを論じ、国際的に通用するスピーチを作る手法を説く。  
また日本にとって国際的な情報発信が持つ意味の重要性と有効な対外発信とは何かを論じる。

## 1. 本授業の概要及び到達目標：

・本講義では、通商政策、貿易経済協力政策、国際エネルギー・環境政策の戦略や実践について学ぶとともに、1980年代以降のアジアにおける産業サプライチェーンの拡大や消費市場の発展を後押しした二国間・地域的なEPA/FTAなどの経済統合、産業・エネルギー協力の変遷を振り返る。

## 1. Course Description and the Learning Objectives :

(Please consider if you should take this course or Professor Iwama's course (GOV2200EA).

This course aims to provide students with an advanced introduction to essential concepts and terms of art for the study International Relations (IR). We examine the IR discipline's primary theoretical approaches, including Realism, Liberalism, and Constructivism, as well as "non-Western" theories such as The China School. The course seeks to communicate the character of world politics from diverse perspectives, including system, actor, and normative approaches, with an emphasis on relating theory to questions of public policy. Thus, the course is both macro-theory and micro-policy focused.

The course will draw on core texts in international relations to provide students with a firm grounding from which to think about and analyze a range of critical issues in global affairs. By the end of the course, students will: have developed a broad understanding of IR, its terminology and theoretical traditions; be able to assess and apply different IR theories to specific issues in world politics from multi-faceted perspectives; be able to identify and develop their own inquiries into the core debates in IR; and have developed communication and academic skills necessary to undertake social science research in IR. Students will also develop debate and teamwork skills through course assignments and activities.

The course requires students to be committed to learning and to come prepared to class, having read the assigned texts in advance. The course will be taught over 15 classes and students are expected to attend all classes in principle. In following GRIPS guidelines for 2-credit courses, approximately sixty hours of out-of-classroom study is expected for the semester. Typically, each class will be divided into a lecture and a seminar. The course instructor will lead the lecture at the beginning of each class, after which we will turn to a seminar-based discussion where students will present and critically discuss the assigned reading(s) for that day.

## 2. Course Outline :

The course is divided roughly into 2 modules. In the first module, we will examine the core theories of International Relations as well as their sub-theories, including an introduction to "non-Western IR." In the second module, we will apply theory to practice and current affairs.

Module I: Class 1 to 8: Realism; Liberalism; Constructivism; The China School, etc.

Module II: Class 9 to 15: Great Power rivalry and US-China competition; Technological revolutions and artificial intelligence, Security and climate change, The Russia-Ukraine War, etc. (Topics for this phase will be decided in part depending on student interest – a poll will be taken on the first day of class).

The detailed course outline will be presented on the second day of class after Module II has been decided.

### 3. Grading :

Students will be assessed on the following components: Participation, Debate, Mid-term Exam, and Term Paper.

**Participation (20%).** All students are expected to actively participate in class discussion and attendance will be taken. Participation includes but is not limited to asking questions of the instructor and of other students, as well as offering descriptive and/or analytical feedback on readings and classroom discussion. Additionally, each student will serve as a Presenter and as a Discussant for at least one of the weekly reading assignments during the semester. The role of the Presenter is to critically review the weekly reading in a concise manner while the role of the Discussant is to critique the Presenter's review, pose questions to the Presenter, and facilitate discussion with the class.

**Debate (10%).** As part of a team, you will argue the affirmative or negative side of a debated topic in international relations. In the class at least one week prior to the debate, students will be assigned to a team and to the debate topic. Evaluation criteria will include the quality of presentation, of arguments, and of team coordination. There will also be a peer component to the grade (how well your peers evaluate your team's performance). All members of the team receive the same grade for the debate. Through this exercise students will not only learn the subject matter but also debate and teamwork skills, both essential to professional development in international affairs.

**Midterm Exam (25% or 35% or 45%\*).** A written, 75-minute in-class exam covering all lectures and required readings. Questions will take a variety of forms, including multiple choice and short answer. Students will be given more questions than they will be graded on, allowing them to focus on question they prefer to answer. For example, if 6 short answer prompts are given, student will be graded on the top 5 answer that they provide (and the sixth question/answer will be discarded from the grading). The goal of the midterm is to reinforce learning and promote knowledge retention and communication under time constraints without the availability of AI or other support resources.

**Term Paper (25% or 35% or 45%\*).** Students will write a final term paper on a topic of their choosing and in consultation with the course instructor. Papers will be approximately 3,000 words (5,000 words maximum). The term paper is a research essay on a topic related to international relations broadly defined. Students should apply a theory or framework covered in the course or elsewhere to a topic of their choosing. Essays will be graded on: quality of writing (precise and concise research question, argument, and evidence to answer the question in

support of the argument); demonstrated applicability of theory and concepts covered in the course or beyond to the research question etc.); quality of analysis (persuasiveness of supporting evidence, consideration of counterarguments, etc.), and appropriate reference to academic and policy literature. These can be deductive or inductive in design. Term papers are designed to contribute to the learning objectives of applying different IR theories to specific issues in world politics while developing one's own inquiries into the core debates in the discipline towards developing skills necessary to undertake social science research.

\*Because everyone learns differently and has different skillsets e.g., test-taking vs. research and writing all students can select the grade distribution that best fits their preferences within three pre-defined weightings. Thus, for example, students may select to have the midterm count as 25% of their grade and the term paper as 45%, or vice-versa. Finally, extra credit may be earned by publishing on an international relations topic in a journal or newspaper. Details will be explained on the first day of class.

## 1. Course Description and the Learning Objectives :

The participating students will learn through this course some tax avoidance/strategies and countermeasures against them as they are adopted in some OECD countries and others. Those countermeasures include in particular rules to cope with cross-border tax evasion, tax avoidance by family members, cross-border income shifting, treaty shopping etc. At the same time, dispute resolution mechanism is also discussed in search of possible options for strengthening the protection of taxpayers' rights and enhancing their access to justice (SDGs Goal 16). Those issues are discussed not only in the context of Japan but also in the context of some other major countries. Some relevant court cases and tax tribunal decisions are also used for analyzing those countermeasures and dispute resolution mechanism.

[Related diploma policies]

Public Finance Program:

1. The ability to understand the administrative, institutional, and legal aspects in the historical context surrounding public policies in general, tax and customs policies in particular, so as to provide practical solutions in reforming tax or customs administration in respective countries.
2. The ability to have a deep understanding of different values and systems in a global society and to play an active role as a balanced leader.

[Course Goals]

Students can gain more knowledge on various issues (such as measures to counteract tax avoidance/evasion and measures to enhance taxpayers' rights and access to justice) that may also be important in formulating reform policies in their countries. Those issues are to be analyzed from multiple perspectives through various relevant systems and experiences of major countries as well as those countries represented by the participating students.

## 2. Course Outline :

Fall

Class 1: Countermeasures against various tax avoidance/strategies on individual income tax

Class 2: Countermeasures against various tax avoidance/strategies on corporate income tax

Class 3: Countermeasures against various tax avoidance/strategies on inheritance tax

Class 4: Countermeasures against various tax avoidance/strategies on VAT

Class 5 to Class 9: Comparative Analysis of Systems regarding Tax Dispute Resolution

Class 10 to Class 13: Presentations and Discussions on Topics chosen by the Students

The topics to be taken up in Class 1 to Class 4 cover notable measures taken up by some countries to counteract tax avoidance/strategy on various tax items. The topics to be taken up in Class 5 to Class 9 focus on the similarities and differences in various countries' systems and rules that exert strong influence on the number of tax disputes and their resolutions. Class 10 to Class 13 give the participating students opportunities to choose topics for their presentations and receive feedback from the other students. Attempts will also be made and exchange of opinions are to be made to explore issues other than the main issues covered above to see if they could be taken up as the possible themes for some students' theses. The lecturer is to provide some relevant information and materials to help determine what kind of approach could be taken to analyze those issues.

[Out-of-class Learning]

Students should read the distributed materials and/or the relevant book before the class to grasp the outline and questions to ask in class.

If the participating students wish, the lecturer will take them to the Tax Library in Tokyo which keeps the largest number of English tax journals and books issued abroad by leading foreign publishers.

3. Grading :

Grades will be given based mainly on contribution to class discussions (30%) as well as presentations at the class (30%) and short quizzes (30%) while considerations are also to be given to the respective participating student's degree of attainment of the goals set for the class (10%).

## 1. Course Description and the Learning Objectives :

### [Outline of the course]

- This course focuses on issues in the works of the WTO that are of relevance to customs administration. The course will be more policy oriented, rather than taking up technical aspects of the issues. This would imply holistic, in-depth analysis and discussion of specific trade policies and their implications on the customs administration, especially as the implementation authority.
- The objectives of this course are as follows:
  - Understand the role of Customs in the global context.
  - Understand the principles and exceptions of the WTO multilateral trading system.
  - Understand how Customs issues are taken up in the context of broader global policy debate.
  - Focus on issues related to customs administration (trade facilitation, tariff policy, trade remedies, dispute settlement, customs valuation, rules of origin, etc.) by taking up negotiating background and developments, together with actual cases that have been brought to the WTO.
  - Follow the recent developments in bilateral and regional trade agreements around the world and their relationship with the multilateral trading system as well as emerging issues related to trade (environment and labour standard) .
- Relevant background information on the themes will be explained in the lectures.
- Schedule subject to change due to possibility of special lectures provided by the WCO Secretariat and officers from Customs and Tariff Bureau, the Ministry of Finance as part of the classes in this course.

### [Envisaged achievement goals of the course]

- By acquiring the knowledge on the principles and historical backgrounds of the multilateral trading system, student is expected to become able to make persuasive arguments within the Government as a trusted government advisor on tariff policy and trade matters.
- By understanding why and how Customs issues are taken up in trade negotiations, student is expected to become able to contextualize Customs issues within the broader global trade policy debate and make persuasive arguments on the way forward for the Customs administration.

#### 【Outline of this lecture】

This course aims to master empirical analysis of social phenomena and conduct practical research on realizing politically influential policy proposals based on each students awareness of the issues. Particular emphasis is placed on formulating students original research plans, verifying hypotheses based on actual data, and compiling analytical results. The course also aims to improve students ability to present their research results in persuasive presentations and critically evaluate their research findings.

#### 【Achievement Goals】

### 2. Course Outline :

This course is an interactive seminar that focuses on student reporting and discussion. Specifically, we will meet on Fridays during the 5th period when there is no Colloquium for 30 sessions (including a full-day presentation scheduled for early July) throughout the year.

In the first half of the course, we will emphasize the development of each students research plan. In the second half, each student will formulate a hypothesis, test it against actual data, and summarize the analysis results. In each session, students will examine the weeks issues in advance and write a comment on the presentation and discussion after class.

Students must conduct their researches out of class in an independent manner in order to prepare for consultation, discussion and presentation in this course.

## 1. Course Description and the Learning Objectives :

### 【Outline of this lecture】

During Workshop which will be arranged for the students in YLP School of Local Governance at the end of the Fall term, students will visit several local governments to meet with officials who will share their first-hand experiences and practices in policy planning and implementation. Students will also have a chance to visit various facilities such as a day care center for elderly people and a roadside station for on-the-spot sales of local products.

## 2. Course Outline :

Workshop will be a four-day trip for 2024 academic year, which will include;

- (i) visit to local governments
  - (ii) visit to NPO in welfare service
  - (iii) visit to local cultural assets
- and others.

### 【Out-of-class learning】

Orientation will be held and an information brochure will be prepared, and students must read and learn the outline of each destination in advance of visit.

After the Workshop, students are also required to review the actual functioning of local governments in Japan to further understanding on it, and discuss and prepare for a group presentation on the assigned destinations that will be held in a week in principle.
