

To meet the needs of foreign government agencies, GRIPS has been offering a wide range of training programs since 2005, in addition to its regular academic programs (masters and doctoral degrees). Human resource development in the public sector steadily increases worldwide. The Executive Development Center for Global Leadership was established at GRIPS in April 2013 in response to increasing demand for short-term training for government officials, particularly for senior executives, middle management level officials and public policy professionals. The Center, contributing the wide variety of experience of its membership, will continue to strive to meet the challenge of developing high-quality training programs.

Our core mission is to continue the development of tailor-made training programs which meet the specific needs of each foreign government organization. However, we also plan to expand our activities by conducting ongoing research to support the development of ready-made programs for both general and specialized training of domestic government officials. Moreover, we are dedicated to promoting exchanges and building networks with human resource development organizations in both domestic and international public sectors. We believe that these efforts will enable us to continue providing exceptional training programs that meet the diverse needs of our client organizations.




